1. The Annual Meeting of Members of the Ontonagon County Rural Electrification Association was held at the Chassell High School on June 21, 2025. The President, William "Bill" Hodges, called the meeting to order at 10:17, asked all to please stand for the Pledge of Allegiance, then welcomed the members.
2. President Hodges introduced himself and asked the board members to stand as he introduced them. He also introduced other representatives of Ontonagon REA, asked them to stand, then invited past directors, retirees or employees to stand and be recognized as well. He then asked for a round of applause as a showing of appreciation for their commitment and service.
3. Secretary Ann Gasperich reported there was no need for an election committee. Randy Myhren in District 1, Green/Firesteel/Toivola ran unopposed, Jack Lehto in District 3, Pelkie/Harman/Aura ran unopposed and Mike Gaunt in District 5, Chassell/Keweenaw Bay ran unopposed All will serve for another three years.
4. Gasperich then read the proof of mailing.
5. Vice Chair Calvin Koski reported there are fifty-four people present, and an additional sixty-one proxy votes (Mr. Haskell suggested the number of proxy votes per person should not exceed five). A quorum is attained by the fifty-four in person, and the additional proxy votes, either sixty-one or seventeen. Calvin then asked all to please refer to the handout of the minutes, as he would entertain a motion to dispense with the reading. Motion/Second - Don Takela made a motion that the reading of the 2023 minutes, and notes of last year's meeting be dispensed with as there were copies available to read, seconded by Lynn Lehto. Motion passed.
6. Chair Hodges spoke to the main purpose of the Annual meeting is to provide important information to the members and stated there are several reports to be presented. He called on CEO Dallas Aho to provide the Financial Report. The Audit for period ending December 31, 2023, and 2024 are both complete. Ontonagon REA continues to be examined by an independent auditing firm. CEO Aho then asked Operations Manager, Justin Sironen, to provide an update.
7. Unfinished business, Jack Lehto provided an update to the net metering policy.
8. New business, motions from the floor:
9. Bruce Johanson provided a request to amend administrative policy # 300-1 paragraph D regarding attendance at board meetings by other than board members, be open to members of the cooperative, effective immediately. Attorney Greeley reminded the members that any motion not provided the required 60-day notice will be received as a recommendation to the board. M/S Mr. Johanson made the motion to recommend his proposal to the board with a second by Mel Haskell. After much discussion for and opposed, the recommendation to review the policy, passed, vote 57-40, or 37-12. It was at this time Mr. Haskell commented that a person should not be able to bring in more than five proxy votes.
10. M/S Mel Haskell made a motion the meeting minutes include verbatim comments from Mr. Haskell as presented in writing, seconded by Johanson, open for discussion, in favor and opposed. Motion failed, vote 42-53 or 22-25.
11. M Mel Haskell to post the Form 990 on the web page, after discussion, Mr. Haskell withdrew his motion.
12. New Business Comments were heard from Mr. Haskell, Morgan Impola, Ellen Lutz, Jennifer Dleine, Don Takila, Jim Moore, Mike Urbis.
